In consideration of the Municipal Authority of the Township of Robinson (the "Authority") furnishing, and the owner(s) and/or tenant(s) of the above-listed property (collectively, "Customer") receiving, water and/or sanitary sewer service ("Service") at the above-listed property, and intending to be legally bound hereby, the Authority and Customer hereto jointly and severally covenant and agree that this application constitutes a contract that shall be governed by the Authority's *Rules and Regulations Governing Water and Sewer Service* (the "*Rules and Regulations*"). Customer hereby covenants and agrees that it shall pay the Authority's lawful rates in effect at the time(s) Service is rendered. Customer acknowledges the Authority's right to seek any remedies for non-payment of charges, including termination of service and/or filing of liens. The owner of the above-listed property further covenant and agrees that if said premises to which Service is provided is occupied by a tenant or tenants, the owner shall be equally responsible with such tenant(s), or subsequent tenant(s), for payment of all charges for Service rendered by the Authority hereunder. In that regard, this application must be signed by both the owner and the tenant(s) of the above-listed property and it shall be the duty of the owner to require the tenant(s) to sign this application as a condition precedent to their occupancy of the premises. The parties further covenant and agree that the Authority, through its employees and agents, shall have free access to the premises at any reasonable times for the purposes of meter reading, collection, service, maintenance, replacement, inspection and any and all purposes related to Service and the Authority's operations.

Customer acknowledges that it has had ample opportunity to examine and review the *Rules and Regulations* prior to signing this application and entering into this contract, and further understands that it may obtain a copy of the Rules and Regulations at the Authority's offices during regular business hours.

The owner hereby further covenants and agrees that if water service is to be provided to the above-listed property and such property is a residential property equipped with a fire suppression system, the owner shall execute the Authority's Waiver, Release, Indemnification and Hold Harmless Agreement regarding fire suppression systems as a condition precedent to the provision of water service by the Authority to such property, unless the owner or any prior owner of said property has previously executed such agreement and the same has been recorded with the Allegheny County Real Estate Department.

WITH RESPECT TO ANY AND ALL WATER PROVIDED AND/OR SOLD BY THE AUTHORITY TO CUSTOMER AND/OR THE ADDRESS IDENTIFIED HEREIN, THE AUTHORITY MAKES NO REPRESENTATIONS OR WARRANTIES, EXPRESS, IMPLIED, STATUTORY OR OTHERWISE, AND HEREBY DISCLAIMS AND EXPRESSLY EXCLUDES FROM THIS CONTRACT ANY IMPLIED WARRANTY OF MERCHANTABILITY AND IMPLIED WARRANTY OF FITNESS.
